3 4	WHEREAS, at least six New Mexicans have tested presumptively positive for the novel		
5	coronavirus, COVID-19;		
6	WHEREAS, COVID-19, a respiratory disease that can result in serious illness or death,		
7	is caused by the SARS-CoV-2 virus, which is a new strain of coronavirus that had not been		
8	previously identified in humans and can spread via droplets from person to person; and		
9	WHEREAS, On March 11, 2020, the International Health Regulations Emergency		
10	Committee of the World Health Organization declared the outbreak a "Pandemic"; and		
11	WHEREAS, The CDC currently indicates there are 118,322 confirmed cases of COVID-		
12	19 worldwide with 938 of those cases in the United States, and New Mexico State Department of		
13	Health has now confirmed travel related spread of COVID-19 in New Mexico; and		
14	WHEREAS, on March 11, 2020, Governor Michelle Lujan Grisham proclaimed a public		
15	health emergency and invoked all powers under the All Hazard Emergency Act, NMSA 1978, §§		
16	12-10-1 through 12-10-10, for a minimum period of thirty (30) days;		
17	WHEREAS, County Ordinance Section 22-32 creates an office of civil emergency		
18	preparedness coordinator who is responsible for the organization, administration, and operation		
19	of the civil emergency preparedness program for the County;		
20	WHEREAS, Bernalillo County has instituted a COVID-19 Response Management Team		
21	to manage all aspects of the incident; and
